



OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

1. HOW TO ENTER

- a. The *KEZI 9 NEWS Dancing with the Stars Getaway* will begin on Tuesday, November 3, 2009 and end on Wednesday, November 25, 2009 (the "Contest Term").
- b. To participate in the contest, you may enter via the following method(s): Watch KEZI 9 NEWS This Morning every Tuesday and Wednesday during the Contest Term between 6:30am and 7:00am. Watch for the special question onscreen during the newscast. Then immediately log on to KEZI.COM to enter and answer the question for a chance to be entered in a random computer drawing to win an all inclusive tickets, airfare and accommodation prize to see the Spring 2010 premiere of Dancing with the Stars in Los Angeles, CA. Travel provided locally by Journeys Travel Ambassadors. One winner will be awarded during the Contest Term on Wednesday, November 25, 2009.
- c. ONE ENTRY PER 24 HOUR PERIOD PER PERSON. Only one winner per household.

2. ELIGIBILITY RESTRICTIONS

- a. The contest is open to all KEZI 9 NEWS viewers who are 21 years of age or older and who legally reside in western Oregon. Employees of KEZI, Chambers Communications (the "Station"), its licensee, its corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other television stations in the Eugene, Oregon metropolitan area and the members of their immediate families are ineligible to participate or win. Subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
- b. Only one winner per household permitted in any Station contest, excluding daily promotional giveaways.
- c. Winners may be required to sign an agreement that absolves Station and other participating sponsors from any and all responsibility regarding awarded prizes once they are received. Winners are also responsible for any and all income and other taxes and fees that arise by virtue of receiving prizes, included but not limited to sales and other taxes. Winners must fill out a standard IRS Form W-9 and are subject to any and all federal, local and state taxes for prize value.

The prizes are expressly limited to the item(s) listed above and do not include taxes, meals, gratuities or any other expenses. Other restrictions may apply.

- a. Decisions of the Station management with respect to The Contest are final.

that day on Station's website (KEZI.COM) and called within five (5) business days by Station staff, excluding holidays. Winners will be chosen solely from online entrants with correct answers to questions, word or phrase as outlined in the The Contest details above.

Winners must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of notification attempt or prize will be forfeited and an alternate winner may be chosen at random from a list of qualified entrants. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, potential winner forfeits prize.

CONDITIONS
